With reference to the subject cited above, I would like to request you kindly to arrange for supply of Certified potato tuberlet Varieties viz. Kufri Pukhraj and Kufri Khyati for cultivation of Potato crop under the scheme RKVY, 2016-17 as per sale price of ASC Ltd. on the basis of Minutes of the Price Finalization committee meeting of ASC Ltd. held on 28th October 2016 to the District Agricultural Officers as per allotment enclosed at Annexure –I latest by 14th November, 2016 for any lapse in implementation.

The order has been placed on the basis of recommendation of Director of Research (Agri) on Potato varieties as per Minutes of the meeting for recommendation of seeds varieties held on 25.08.2014.

Terms & Conditions:

1. If the seeds are not received in the districts H.Q. due to delay in delivery over the stipulated period as given in the order, this Department will not be responsible for making any payment against the order.
2. No split bill will be accepted.
3. Only quality certified potato tuberlet have to be supplied as per stock availability.
4. Any substandard if detected after supply of tuberlets will summararily be rejected and no payment will be made from this end.
5. Quantities should be supplied as per our supply order. Any short quantity found anywhere, drastic action will be taken against the officials involved and the suppliers.
