- 3. Only quality certified potato tuberlet have to be supplied as per stock availability.
- 4. Any substandard if detected after supply of tuberlets will summerarily be rejected and no payment will be made from this end.
- 5. Quantities should be supplied as per our supply order. Any short quantity found anywhere, drastic action will be taken against the officials involved and the suppliers.
