Specifications: Tissue culture origin, six months old secondary hardened plants in coco peat filled plugs. Disease free.

Terms & Conditions:

1. If the TC straw berry plants are not received in the districts H.Q. due to delay in delivery over the stipulated period as given in the order, this Department will not be responsible for making any payment against the order.
2. Only TC straw berry plants have to be supplied as per stock availability.
3. Any substandard if detected after supply TC plant will summarily be rejected and no payment will be made from this end.
4. Quantities should be supplied as per our supply order. Any short quantity found anywhere, drastic action will be taken against the officials involved and the suppliers.
