The 1st State Level Executive Committee meeting was held under the Chairmanship of Sri V.B.Pyarelal, IAS, Additional Chief Secretary, Agriculture and Agriculture Production Commissioner, Govt. Of Assam on 11th June 2015 at 3.00 p.m in the Conference hall of Additional chief secretary & APC, CM Block 3rd Floor, Dispur.

On request from the Chair Sri T.D. Hanse , Director of Horticulture & Food Processing , Assam and the Member Secretary of State Level Executive Committee (SLEC) explained the objectives of the meeting. It was stated by the Director of Horticulture & FP Assam that Govt. of Assam has reconstituted the SLEC vide Notification No: HFPD.14/2014/6 Dated 9th September 2014 as per guideline of Mission for Integrated Development of Horticulture (MIDH) as earlier the name was State Level Steering Committee (SLSC) under HMNEH guideline. He also informed that the main objective of the meeting is to review the progress of HMNEH under MIDH 2014-15 and to discuss various issues relating to implementation of the HMNEH Scheme including the approval of Annual Action Plan of 2015-16 as per agenda note of the SLEC meeting.

Reviewing the proceeding of the last State Level Steering Committee meeting the Chairman requested the Member Secretary to place the Agenda Items and to explain the Action taken report of last State Level Steering Committee meeting under HMNEH. The meeting accepted the action taken report placed by the Member secretary.

During the Discussion on the Agenda Item No: 2.(I) on Progress of HMNEH 2014-15, Director of Horticulture & FP, Assam informed that Govt. of India has allotted an amount of Rs 48.00 Crores for implementation of HMNEH scheme as per approved action plan and out of which an amount of Rs. 1862.63 Lakh has been released as 1st installment which have already been implemented in different districts against which inputs have been arranged from the HQ from L1 accredited Nurseries through NIT and approved by state level Departmental Purchased Committee (DPC) headed by Secretary Agriculture, Govt. of Assam.

It was suggested by the Chairman that as the keeping quality of Strawberry is very poor hence proper post harvest technology should be developed by the Assam Agriculture University. Moreover it was advised by the Chairman that while introducing the innovative crops it should be kept in mind by the department that farmers must get appropriate market linkage. Similar action may be taken up by Assam Agriculture University (AAU), Jorhat, Assam.

It was also discussed in the meeting that as the keeping quality of Malbhog banana is better than the TC Banana variety G-9, TC Banana seedling Var: Malbhog should be made available for the farmers. The Department and AAU should take initiative to produce required quantities of Malbhog Tissue Culture Banana seedling in the State.

It was suggested by the Committee to maintain the beneficiary list of different components by the District Agril. Officer at District Level which have been implemented during the year 2014-15, so that the state Monitoring & Evaluation Committee may verify it during field visit in different district.

Considering Farmers' demand the Committee suggested to consider some other varieties of onion like N-53, Globe, Pusa Red etc. besides Agri-Found Light Red Variety. In this connection the AAU is requested to suggest some tested variety and to recommend for Assam climate.

Discussing the floriculture components, it was suggested by the Committee to develop Technologies by the AAU to preserve the bulb of Lillium and to report for necessary action.

During the discussion on Agenda Item No: 2.(II), it was informed by the Director of Horticulture & Food Processing that Govt. of India allotted an amount of Rs. 1045.89 lakh as the 2<sup>nd</sup> installment for implementation HMNEH Scheme 2014-15 at 100% Govt of India fund sharing pattern. As the fund was released on 31st March 2015, the components could not be implemented during 2014-15. However, Govt of India has revalidated the amount and as such the following components which were approved by the Govt. of India which have been proposed for implementation during the financial year 2015-16, from the Head Quarter like 2014-15 considering the closure of Bank Account of respective District Agricultural Officers. The Committee approved as below:

- Discussing Agenda Item No: 2. (III) on the approved Annual Action Plan of 2015-16 and timeline of implementation by the Director of Horticulture & FP Assam from the Head Quarter as per approved rate of Departmental Purchase Committee and it was also informed that the Annual Action Plan was approved by the Chairman SLEC as well as by the Hon'ble Minister of Agriculture which was prepared for an amount of Rs 58.65 crore on the basis of 100 % central assistance. Subsequently, Govt of India has accorded allocation of Rs. 30.50 Crores out of Rs. 61.00 crore on 50:50 sharing pattern and requested to include the component of R&D. As such the AAP has been prepared at <a href="mailto:Annexure-I">Annexure-I</a> for Rs. 61.00 Crores\_which is approved by the Committee.
- The Committee discussed the Agenda Item No: 2.(IV) on Centre of Excellence (Veg), Barama, Nagaon and engagement of consultant for preparation of DPR and technical guidance. It was informed by the Director of Horticulture & FP that a Centre of Excellence (Veg) at Departmental farm Barama in Nagaon district has been included in the AAP 2015-16 with involvement of Rs. 10.00 crores in two phases @ Rs 5.00 crore each. For 2015-16 Rs. 5.00 crores has been allotted and approved by the committee. For preparation of DPR and to have technical advice it has been proposed to engage a consultant /Firm having knowledge on hi-tech horticultural activities. The consultant should have international reputation and experience of working in India in general and in NER in particular. The consultant/Firm will be selected by floating EOI/Tender etc. The Committee approved the proposal and advised Director of Horticulture & FP, Assam to go ahead for floating of Expression of Interest (EoI) and allowed to engage a consultant to L1 Firm or individual Consultant having experience on Hi-tech Horticulture. Further the DPR has to be completed within August, 2015 and the operation of the project should start from Sept,2015 and by the end of Dec./15 the project for 1st phase should be completed for Rs 500.00 lakh (Five crore).
- During the Discussion on the Agenda Item No: 2.(V) on DPR of Centre of Excellence, Citrus, Bamunigaon Director of Horticulture & Food Processing Assam informed that the DPR of CoE, Citrus, Bamunigaon was modified in the light of the CoE, Sirsa, Haryana which is to be implemented at Bamunigaon, Boko in Kamrup District under HMNEH 2013-14 for an of Rs 500.00 lakh (Five crore). Now, the DPR has been prepared by the individual Consultant with Technical Sanction accorded by the Chief Engineer (Agri) of Agriculture Department which is approved by the SLEC. Abstract of project cost of the DPR is placed as below which has been approved by the Committee and advised to implement the project immediately and to complete within October, 2015 so that the operation of the project could be started from December, 2015.

The Committee approved the component and allowed to implement the works by Director of Horticulture & FP, Assam during 2015-16 from HQ as per Guideline and as per approved L1 rate of Departmental Purchase Committee.

The Committee discussed the Agenda Item No: 2.(VII) regarding\_ retention of HMNEH fund of 2013-14 by the Mission Director of MIDH who is also the Director of Horticulture & FP Assam for smooth utilisation of HMNEH project as the fund was drawn directly from Govt of India through Assam Small Farmers Agri- Business Consortium (ASFAC). The projects are Centre of Excellence Khetri, Centre of Excellence Boko and Model Floriculture Unit at Sarutari farm under implementation on Turnkey basis and will be handed over within December 2015. It was informed by the Director of Horticulture & FP Assam that Govt of India vide letter No: F.No 18-33/2014-NHM Dated 16th April 2015,

requested to maintain a S/B Account for the on going Scheme under HMNEH instead of Current Account. The Chairman advised to take up the matter with the appropriate authority to maintain such Account till December, 2015. It was also suggested by the Committee to expedite for utilizing the entire fund within December 2015.

The Committee reviewed the need and performance of the Data entry Operators and the Junior Engineer engaged for day to day work and as the earlier engagement period of these contractual persons were over it was decided to extend their service for another 11 months and approved accordingly.

The Committee discussed the Agenda Item No: 2.(IX) regarding the proposal for engagement of skilled labour in Byrnihat departmental farm, Panjabari farm and Centre of Excellence Khetri. It was informed by the Officials of Directorate of Horticulture &FP Assam that these centres/Farms need manpower to run these projects in a self sustainable manner. To avoid the crisis of skilled man power, there is a need to place at least 2 trained Malis in each farm/centre. In this regard, it is advised by the Committee the Malis will have to be selected from the trained persons who have undergone one month training at HRS, Kahikuchi organised by EGM, HRS and Directorate of Horticulture. The Malis will be engaged in different Farm/ Centres as shown below;

- The committee approved to engage these six Malis and their rate of wages will be determined as per wages rate of labour department for skill manpower.
- It was informed by the Director of Horticulture & FP, Assam that there was an allocation of One Model Floriculture Unit under HMNEH 2013-14 which was allotted to Horticulture Research Station, Kahikuchi under AAU and accordingly the fund was kept at Directorate of Horticulture Assam. The Committee advised to release the amount of Rs 100.00 lakh to AAU immediately for implementation of the component of Model Floriculture Unit at Kahikuchi by AAU as per Guideline laid down under HMNEH.
- Discussing the other related matters of AAU the Committee approved the proposal placed by the Director of Research and Chief scientist HRS Kahikuchi for interchanging of minor components of Public sector Big Nursery allotted during 2012-13 by the Director of Horticulture & FP, Assam.
- Discussing the 'Any Other Items' of the agenda, the Committee approved engaging
  of one Horticulture Consultant specially for Floriculture for HQ and 10 (ten)
  number Data entry Operators for different districts in phased manner on need basis
  during 2015-16. It was advised by the committee to engage the consultant who is

having experience in the field of floriculture and Data Entry Operators based on their skill on Computer application, in a transparent manner. In this connection Director of Horticulture & FP, Assam may float an advertisement for walk-in Interview for selection through a selection Committee. The engagement may be done on merit basis and the remuneration of Horticulture consultant and Data Entry Operator should be as per the guidelines of MIDH.

• Director of Horticulture & FP Assam placed the proposal of fixing the sale price of different saplings/planting materials produced in the departmental farms. The Committee approved the rate based on the rate of Assam Seed Corporation Ltd.

project was approved by 15<sup>th</sup> SLSC held on 27.02.2013 which was under consideration at MOFPI New Delhi. As the Annual Action lan of 2015-16 was already approved and communicated to Govt of India, hence it was decided to request for additional allocation subject to receipt of state share.

The meeting ended with thanks from the Chair.
