c) **PROTECTION & SAFETY OF PLANTS DURING TRANSPORTATION:** The Supplier shall provide proper protection and safety of planting material with suitable materials (e.g. poly packed with soil) required to prevent their damage or deterioration during transit. During transit, the protection and safety material shall be sufficient to withstand, without limitation, rough handling and exposure to extreme temperatures. The insurance of the species-specific planting materials to be supplied is the responsibility of the vendor from supply to the final destination till its plantation in the main field.

12) CONFORMITY OF GOODS, PLANTING & MAINTENANCE SERVICES: Bidder shall furnish as part of the Quotation, documentary evidence that the species specific planting materials supplied conform to the technical specifications and standards, supported by relevant documents, etc. Bidder shall attach a clause by clause confirmatory to the laid down specifications. Also, the bidder shall submit an undertaking subject to the rendered service as confirmatory to bearing the responsibility of planting the planting materials with proper spacing in the main field of the destined location followed by maintenance of those planted saplings for atleast a period of 1 year.

14) AWARD OF CONTRACT:

The Director, Horticulture and Food Processing will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price for the supply, plantation and maintenance of the planting material.

- a) Notwithstanding the above, the purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract without any liability to the vendor.
- b) The bidder whose quotation is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.

- **15) Payment:** Payment shall be made upon successful delivery and acceptance of the planting materials by the concerned Officials/ Seed Farm I/Cs of the delivery locations/Seed Farms and shall be made by **Director of Horticulture and Food Processing**. If after supply, it is discovered that the species specific planting materials supplied are not exactly according to the specification/quality mentioned, such supply will be rejected at the supplier's cost. The decision of **Director of Horticulture and Food Processing** on quality & specifications shall be final and no disagreement from the supplier shall be entertained.
- a) 80% Payment shall be made within 30 (thirty) days after delivery and planting of the species specific planting materials at the final destinations (Seed Farms of Assam Seeds Corporation Ltd.) and on the receipt of certification by the concerned Officials/ Seed Farm I/Cs of the delivery locations/Seed Farms that the plants have been received in good condition and the whole lot was planted following proper plant to plant spacing
- b) Remaining 20% Payment shall be made after completion of 1 year maintenance period from the date of implementation of the program. If any plants die or show abysmally poor growth compared to normal growing plants, payment for those number of plants shall be withheld.
- c) Taxes shall be dealt as per applicable laws.
- d) No advance payment shall be made.

16) FORCE MAJEURE:

- a) The bidder shall not be liable for forfeiture of its Performance Security, liquidated damages, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. For purposes of this Clause, *"Force Majeure"* means an event or situation beyond the control of the Supplier that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the Supplier. Such events may include, but not be limited to, acts of the Purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.
- b) If a Force Majeure situation arises, the bidder shall promptly notify the Purchaser in writing of such condition and the cause thereof.
