The necessary bills in triplicate with receipted challans with stock entry duly countersigned by the concerned District Agricultural Officer as well as competent authority of ASC Ltd. with seal must be submitted to the undersigned for necessary payment.

**Terms & Conditions:**

1. **If the hybrid vegetable seeds are not received in the districts H.Q. due to delay in delivery over the stipulated period as given in the order, this Department will not be responsible for making any payment against the order.**
2. **Any substandard if detected after supply of hybrid vegetable seeds, will summararily be rejected and no payment will be made from this end.**
3. **Ensure the receipt date of seeds, entry of stock book, and receivers' signature with office seal along with countersignature of D.A.O. on the body of the Challan.**
4. **Mention clearly the vehicle number and type of vehicle used for delivery of seeds on the Challan.**
5. **Photographic evidence of vehicle / carrier should be submitted along with challan.**
6. **Quantities should be supplied as per allotment. Any short quantity found anywhere without any valid reason, action will be taken against involved person as per Govt. procedure.**
